



# Tax Notice

About November 1, real estate owners in the Paducah city limits will receive City yearly tax bills. Governmental bodies that set and receive these taxes are as follows:

<u>Agency That Sets Tax Rate</u>	<u>Rate Per \$100.00</u>	<u>Who Receives Taxes</u>
1. Paducah City Commission	25.0¢	City of Paducah
2. Paducah City Commission	1 7/10¢	Paducah Junior College

- Total year 2012/2013 real estate tax assessment in Paducah City limits is \$1,519,604,966. Of that amount, \$811,591,561 or 53.4% of the total assessment of real estate in the City is in the County School District. County School District property in the City is primarily in the westerly part of the City. Owners in this area do not pay City School taxes.
- Property owners in the City of Paducah will receive a separate tax bill from the McCracken County Sheriff. Taxes on that tax bill are set by other governmental agencies, not the Paducah City Commission, but city property owners must also pay those taxes.
- Homestead exemption is \$34,000. If you qualify, this is subtracted from assessed value.

### EXAMPLE AND HOW TO FIGURE YOUR TAXES

(Assumes a \$50,000 assessment – year 2012/2013 rate)

\$50,000 ÷ 100 = 500. 500 X .25 = \$125.00 To City of Paducah	\$50,000 ÷ 100 = 500. 500 X .017 = \$8.50 To Paducah Junior College	<u>(In City-City Schools)</u> \$50,000 ÷ 100 = 500. 500 X .747 = \$373.50 To Paducah City Schools	<u>(In City-County Schools)</u> \$50,000 ÷ 100 = 500. 500 X .504 = \$252.00 To McCracken County Schools

IN CITY – IN CITY SCHOOL DISTRICT Example total tax is \$507.00

IN CITY – IN COUNTY SCHOOL DISTRICT Example total tax is \$385.50

(Divide your assessment by 100 and multiply the result by listed tax rate to get tax to each agency)
